Dividing Application (We do not file applications which should ever need division; this applies only to applications taken over)	\$800	\$100 (per newly created application)
Additional fee for late filing when permitted by USPTO	\$100	\$100 (per class)
Preparation and filing of Affidavit of Continued Use or excused use (Section 8) (to be filed during 5 <sup>th</sup> to 6 <sup>th</sup> year after registration--the earlier, the better)	\$350	\$225 (per class)
Preparation and filing of Declaration of Incontestability (Section 15) (to be filed during 5 <sup>th</sup> to 6 <sup>th</sup> year after registration--the earlier, the better)	\$500	\$200 (per class)
Preparation and filing of Combined Section 8 and 15 Declaration (to be filed during 5 <sup>th</sup> to 6 <sup>th</sup> year after registration--the earlier, the better)	\$750	\$425 (per class)

Electronic filing of application with physical deposit of work (necessary for books, etc.)	\$300	\$65
Responding to Copyright Office queries, appeals, etc.	Hourly rates	Variable official fees
Filing to have Knull PC act as DMCA agent for your websites	\$75 for filing & hourly rates for handling any complaints	\$6 and up, depending on number of websites covered
